

IMPORTANT COVID-19 UPDATE

May 5, 2021

With the announcement from Governor Carney about the easing of indoor capacity restrictions and reduction of social distancing, we feel it is now safe to return to more “normal” procedures for seeing our patients.

Beginning May 24, 2021 we will resume walk-ins for battery purchases and for minor hearing aid services, such as filter or dome changing. As before, an appointment is always needed for hearing tests or for hearing aid adjustments. If you are not sure if you will need an appointment, please call us at 302-478-4942 and we will let you know if you can walk-in or if you need an appointment.

We will continue to adhere to the State of Delaware rules about mask wearing indoors until such time as there is a change in that policy. So, for now, **you must wear a mask to enter the office.**

PLEASE PLAN ON ORDERING BATTERIES THROUGH THE MAIL OR OVER THE PHONE. WE HAVE ORDER FORMS AVAILABLE FOR YOU IF YOU WOULD LIKE TO PAY BY CHECK THROUGH THE MAIL

YOU WILL NEED TO BE ON-TIME FOR YOUR APPOINTMENT. WE ARE TRYING TO MAKE SURE THAT NO ONE IS WAITING IN THE WAITING ROOM SO IF YOU ARE EARLY FOR YOUR APPOINTMENT, WE WILL NOT ALLOW YOU IN TO THE OFFICE UNTIL WE ARE READY TO BRING YOU IN TO THE FITTING OR TESTING ROOM

IF YOU ARE MORE THAN 10 MINUTES LATE FOR YOUR APPOINTMENT, WE WILL HAVE TO RESCHEDULE YOUR APPOINTMENT

We hope to be able to ease some of these restrictions at the State of Delaware moves to Phase 2 and beyond. We ask for your continued patience as we work to make sure everyone remains safe and healthy.

We want our patients and our staff to stay health and safe. Please help us by calling or emailing prior to coming out to see us.
