I understand that I may revoke this consent in writing, except to the extent that the organization has already take action in reliance thereon. I also understand that by refusing to sign this consent or revoking this consent, this organization may refuse to treat me as permitted by Section 164.506 of the Code of Federal Regulations.

I further understand that Cove Audiology and Hearing Services reserves the right to change their notice and practices and prior to implementation, in accordance with Section 164.520 of the Code of Federal Regulations. Should Cove Audiology and Hearing Services change their notice, they will send a copy of any revised notice to the address I've provided (whether U.S. mail or, if I agree, email).
